We are proud to announce that "The Mentorship Project" has teamed up with the National Law Institute University, Bhopal (NLIU) through Centre for Law and Technology (CLT) for their annual tech fest "Techtonic 2023". This exciting event brought together students, professionals, and experts from across India to engage in discussions and competitions related to technology, law, and finance.

As part of this collaboration, Raghav Singh (Founder, The Mentorship Project) was one of the panelists on the topic of "Metaverse". The discussion focused on the impact of emerging technologies like virtual reality and augmented reality on our society, economy, and legal system. The panel also included Nitish R Daniel (Legal Advisor ONGC) and Anubhav G Talvar (Data Privacy expert at National Health Authority) who shared their insights on this rapidly evolving topic.



In addition, a policy case competition that challenged participants to develop innovative solutions to real-world legal problems related to technology and finance was also organized.
